Dear Parent,
Greetings!

New session 2021-22 of the school will begin with effect from 5th April 2021. Following points are to be brought to your notice in this regard:

1. Classes from Preparatory to VIII will be conducted in both online and offline modes on alternate days for now. The lessons taught in offline mode will be taught again in online classes. Time Table for online and offline classes is being notified separately.
2. Students of class I, III, V and VII will come to the school on Mondays/Wednesdays/Fridays and classes Prep, II, IV, VI and VIII will come on Tuesdays/Thursdays/Saturdays.
3. Offline classes for IX to XII will be conducted on all working days. Online teaching for these classes will also be done with prior notice as per requirement.
4. All students willing to attend the school will bring a **written consent** from parents in the format given on page 2 of this letter.
5. On demand from parents school buses will ply on selected routes. Transport service will be extended in future as per requirement.
6. Please check the temperature of your ward before sending him/her to the school. If the temperature is found above or below normal, student must not be sent to the school.
7. It will be compulsory to wear a face mask covering the nose and mouth properly for full-time in the school. Wearing hand gloves is recommended.
8. Physical distancing will be maintained all the time.
9. Please provide a small bottle of hand sanitizer and an extra face mask to your ward while sending him/her to the school.
10. In case, any member of the family is found unwell, the student should not be sent to the school. Please send such information to the school by mail or to the class teacher by WhatsApp messenger at the earliest possible.
11. From 5th April 2021, the school will run as per usual timing.
12. Students should carry their own water bottles to the school. Exchange of any article or edible from others is not allowed.
13. Children should be helped to develop habit of washing hands with soap and water before touching face, nose or before eating food.
14. The school will follow the Standard Operating Procedure issued by the Govt.
15. Your cooperation will help us to provide a safe school environment.
