Subject: ACCOUNTANCY

1. Pass necessary journal entry for **issue** of debentures for the following:

Y Ltd. Issued 1000, 12% debentures of Rs.100 each at a discount of 10% redeemable at a premium of 5%.

Z Ltd. Issued 2000, 9% debentures of Rs.100 each at a premium of Rs.10 per debenture and redeemable at a premium of Rs.20 per debenture.

2. Record the Journal entries for the forfeiture and reissue of shares in the following cases:

i. X Ltd., forfeited 20 shares of Rs. 10 each, Rs. 7 called up on which the shareholder had paid application and allotment money of Rs. 5 per share. Amount not received on call is transferred to Calls in Arrears Account. Out of these, 15 shares were reissued to Naresh as Rs. 7 per share paid up for Rs.8 per share.

ii. Y Ltd., forfeited 90 shares of Rs.10 each, Rs. 8 called up issued at a premium of Rs. 2 per share to R for non-payment of allotment money of Rs. 5 (including premium). Out of these 80 shares were reissued to Sanjay as Rs. 8 called up for Rs. 10 per share.

iii. Z Ltd., forfeited 50 shares of Rs. 100 each issued at 10% premium (to be paid at the time of allotment) for non-payment of first call of Rs. 30 per share. The second and final call of Rs. 20 per share was not yet made. 20 of these shares were reissued at Rs. 80 paid up for Rs. 30 per share.

3. Bramhaputra Ltd. issued 20000 shares of Rs 10 each at a premium of 10 %, payable as follows:-

On Application: - Rs.3

On Allotment: - Rs. 4 (including premium)

And balance on final call.

The issue was oversubscribed to the extent of 15,000 shares and the allotment was made as follows:- (a) Applicants of 5,000 shares were given full allotment (b) other applicants of 30,000 shares were allotted on pro-rata basis. All moneys due were received with the exception of the allotment and call money on 1000 shares held by A and call money on 500 shares held by B. The shares on which allotment and call money was not received were forfeited. The forfeited shares were reissued at Rs. 7 per share as fully paid up. Pass necessary Journal entries in the books of Bramhaputra Ltd. for the above transactions.
